APPOINTMENT OF AN ADDITIONAL DIRECTOR

Singapore, 31 May 2023 – Seatrium Limited (“**Seatrium**” and together with its subsidiaries, the “**Group**”) wishes to announce the appointment of Mr Sarjit Singh Gill as a Director of Seatrium from 1 June 2023. He has also been appointed to serve as a member of the Singapore international Arbitration Centre (SIAC) Panel of Arbitrators and has served as a member of the Singapore International Mediation Centre Specialist Mediator Panel (Singapore) from 2020 to 2022.

Mr Gill is a board member of the Inland Revenue Authority of Singapore, as well as the Urban Redevelopment Authority. He is also a non-executive director of Heliconia Capital Management Pte Ltd and served on the Board of the Central Provident Fund from 2012 to 2018.
